## Outreach Funding Request Program & Application

### Overview

The Outreach Funding Program of University Christian Church (UCC) provides financial support to non-profit organizations that promote Christian beliefs and principles through services or program. It is the commitment of UCC to reach out to the world with God's spirit of love, help and hope, sharing ministry with all, near and far. The following guidelines have been established to assist your organization in presenting a grant request in a manner consistent with our review and decision-making process. Following these specific guidelines in preparing your proposal and in submitting the requested attachments will enable the Outreach Committee to make a prompt and well-informed decision on your request.

**The 2022 deadlines for consideration of Grant support are March 1st and September 6th.** If your funding request is time sensitive and falls outside of these dates, special consideration will be given. Should you have any questions concerning whether or not your proposal fits within the scope of the giving guidelines or priorities, send a brief letter of introduction explaining your organization and the specific project.

### Funding Priorities

The Outreach Funding Program seeks to make investments in communities in the hope that they can be built upon, leveraged with other gifts, and remain intact as the cornerstones of community improvement. It is the belief of the Outreach Committee that we are companions in our service to the world.

Priorities include programs that are Christian in nature with emphasis on organizations associated with Disciple of Christ ministries, human service organizations with emphasis on family, children and youth programs, and programs that foster education. Organizations with small operating budgets in which the gift will make a greater impact are particularly welcomed.

### Contribution Policies & Guidelines

Decisions for funding requests are made by the members serving on the UCC Outreach Committee. Funding is made only to organizations that are tax-exempt from federal income taxation pursuant to Section 501©(3) and are not classified as private foundations with the code. Funding is primarily awarded to Fort Worth area programs, projects and services. Strong emphasis is placed on organizations within the Disciples of Christ denomination, including local, national and international programs within the interest of the congregation.

The types of support granted through the Outreach Funding Program range from \$500 to \$20,000 and include funding for general/operating support or specific project support. Organizations receiving funding will be required to provide a written report at the end of twelve months detailing the impact of the gift. Organizations may submit a new application every twelve months.

Except in most unusual circumstances, the Outreach Funding Program does not make grants to:

- o Individuals – except as scholarship funds
- n Publications
- n Deficient funding
- n Telethons, dinners, advertising or other sponsorship fundraising situations
- n Groups that have not been in existence for more than three years
- o Foundations, fraternal organizations and endowment funding

  - n A statement of its primary purpose and the need or problem that the organization is seeking to address.
  - n The population that is served.
  - n Strategies used to achieve positive results
  - n Anticipated length of project
  - n How the program, service or project contributes to the organization’s mission statement.
3. Please explain how the organization will measure the effectiveness of the activities. Describe the criteria for a successful program, service or project and the results the organization expects to have achieved by the end of the funding period.

3. A recent annual report, if available
4. An operating expense budget

6. A brief report detailing the impact of past contributions from UCC (if applicable)
